Encourage fathers to actively participate in ARP activities alongside their daughters, fostering a sense of shared responsibility and commitment to protecting girls. Identify and showcase male community leaders and influencers who champion FGM abandonment as positive role models.	Partners will identify male champions from our activities who will serve as positive role models saying NO to FGM.	Q1 2025 led by partner project officers.
Design specific workshops and sensitization sessions tailored to perspectives and concerns of older women and mothers-in-law, who often hold traditional beliefs about FGM.
